The RTAC Membership Committee met on Wednesday, November 9, 2:00 PM in the CTPS Conference Room. Attending members included: Richard Canale, Lexington; Steven Olanoff, RTAC Chair; Monica Tibbits, Committee Chair; Steve Rawding, MassDOT Aeronautics; Laura Weiner, Arlington; Brian Kane, MBTA; and Pam Wolfe, Mike Callahan, and David Fargen, MPO staff.

David Fargen was introduced as the new MPO staff manager for the Advisory Council.

Directions for new member outreach:

Members discussed their wish that membership reflect a broad base of transportation related interests. The Advisory Council would like more voices at the table. Staff was asked to reach out to particular groups of interested parties, including: businesses, regional transportation advocates and other transportation coalitions, transportation providers, transportation equity (EJ) organizations, universities, hospital and health care facilities, as well as JARC and New Freedom funding recipients. Some of the groups identified for outreach included the Livable Streets Alliance to address areas of livability and sustainability, MassInc, T4MA, the Environmental League, T-Riders Union, and the Conservation Law Foundation, Alternatives for Community and the Environment.

For areas of environmental interest, the Massachusetts U.S. Green Building Council was mentioned. It was suggested that groups which focus on land use or community development interests be considered. (Some members suggested community development corporations and neighborhood initiatives might bring interesting views to the discussion. Other members thought their missions and areas of interest were not regional enough and that they should not be invited.) State agencies such as MA DEP and EOEEA should be included in the outreach. Staff was instructed to develop a longer list of possible entities to reach out to and to present this to the Membership Committee.

Membership Review:

The Committee Members want to take action to rejuvenate current members who are not active participants. They discussed reaching out to current Advisory Board Members with a personal phone call in order to try to encourage active and regular participation. Members who are not attending regularly could be asked why they are not attending. Staff was asked to contact members for this purpose. Staff will note the reason (s) the entity hasn't been attending and if it is because the current designee is no longer available, will encourage another to be appointed. Staff will prepare a list of the benefits of being an active member for use in these conversations. It was suggested that the current by-laws be checked for percentage attendance requirement and that the Advisory Council try to implement a policy of compliance.

After Staff's initial outreach, the Advisory Council Vice Chair and Membership Committee Chair will hold an additional conversation to encourage active participation.

Two tables were presented by staff (attached). Table 1 identified "Percentage of Meetings Attended" while Table 2 pointed out members who attended no meetings over the last year. This table will be used in contacting members for follow-up phone interviews.

Voting Status and Conclusion:

Committee Members discussed the voting status of MPO Members on the Advisory Council and wondered if attendance would be curtailed if MPO members are not given a vote. No resolution on this matter was reached and discussion will be continued to the next Membership Committee meeting.

Members agreed that meeting programs and timely topics are a reliable way of stimulating attendance and participation and that the Advisory Council would benefit from ramping-up outreach activities.

Staff Tasks:

- Staff will update contact information for members who have not attended meetings in the past year
- Staff will conduct telephone interviews with members who have not attended meetings.
 Reasons for not attending the meetings or any obstacles that the members may have will be discussed during the interview
- A table of the entity, the representative, and notes on the discussion will be created and sent to the committee chairperson for her observations and input.
- Where applicable, names for the new contact person will be added to the list

Re: FFY 2011 Advisory Council Membership Review

This memorandum presents information about the participation of voting Advisory Council members in federal fiscal year (FFY) 2011, which ended on September 30, 2011. The Advisory Council held ten meetings in FFY 2011. Attendance is summarized by the two tables below. Table 1 shows the percent of meetings attended by voting Advisory Council members attending at least one meeting in FFY 2011. Table 2 shows the last meeting attended by members that did not attend a meeting in FFY 2011.

Of the 57 voting members, 38 attended at least one meeting (67%) and 26 attended at least 50% of the meetings (46%).
